- 4. Treasurer's Report: Treasurer Janelle Smith reported the following status to the Secretary, as of 31 March 2023: First Interstate Bank Checking Account: \$108,007.43; Fidelity Money Market: \$57,624.93.
- 5. Finance Director's Report: The Secretary discussed following items:
 - A. Al Cans for 2 X 4's: No new developments.
- B. 28th Annual Bowl-a-thon, 1:30 PM, Sat, 1 Apr 23, Chop's Bowl: A total of 22 bowlers bowled with 11 bowlers at Chop's Bowl and 11 bowlers phoning in their scores.
