4. Treasurer's Report: The Treasurer reported the following status, as of 31 March 2026: First Interstate Bank Checking Account: \$115,824.33; Fidelity Money Market: \$65,791.26, for a total of \$181,615.59.
5. Finance Director's Report: The following items were discussed:

  - E. 2026 Fundraising Financial Plan: Progress on the \$110,000 fundraising goal is at \$109,574 or 99.6%.
